Vacancy for Trustee

We are looking to diversify the representation on our Board and have a vacancy for a new Trustee to join our small charity.

The communities we serve are diverse and we aim for our team to reflect those communities. We particularly encourage Trustee applications from people with disabilities and people who identify as trans and non-binary, who are currently under-represented within our Board.

All applications will be considered solely on merit. As such, we redact details that may identify any protected characteristics or educational establishments on applications.

This role gives the opportunity to make a difference. The successful candidate will gain experience and skills at board level and the opportunity to network. They will gain personal development in decision making skills/evaluating applications.

About the Talbot Trusts

The Talbot Trusts is a grant-making registered charity which distributes funds to support health-related charitable work for Sheffield residents and those on the surrounding boundary. We fund registered charities and other types of not-for-profit organisations, such as Community Interest Companies (CICs) or constituted community groups if they can explain how they would use our funding for charitable purposes.

We are keen to receive applications from organisations who represent the following groups:

Adults and children who are living with a physical or learning disability
People living with a mental health condition
Elderly people struggling with social/physical isolation
People living with Cancer
Black and Minoritised Communities

Our current funding strategy focusses on the following:

- Reducing the impact of poverty with a focus on homelessness and insecure housing
- Improving health outcomes in cancer, CVD and respiratory diseases
- Improving mental health in children and adults

Role

We welcome applicants who are familiar with the Sheffield and surrounding areas and have a real interest and understanding of the issues faced by the people who are living with the conditions, mentioned above.

We are looking for someone to actively participate in the Board meetings and show a real commitment to ensure our funds are used to maximise the benefit of the people in the above groups. The role involves assessment of grant applications and whether they align with our objectives.

We are particularly keen to recruit someone with an interest/skills in IT, marketing and social networking so that we can increase our exposure and connect with harder to reach groups.

There will also be a requirement to contact local organisations either to discuss grant applications or to reach out to organisations that we have not funded before, who may be able to benefit from completing an application. This could be via phone, Zoom/MS Teams or visit, when permissible)

Time Commitment

We meet approximately 6-8 times a year. Meetings are currently held via MS Teams between 4pm and 6pm on a weekday.

Approximate time commitment (per annum):

- 2 x meetings (2 x hrs each) - to agree grant application funding
- 4 x meetings (1 x hour each) - to discuss and agree strategy and policies etc.
- Adhoc visits/calls to local organisations (2-4 hours)
